MSA Professional Services, Inc., an environmental consultant, prepared an environmental assessment for RD that describes the project, assesses the proposed project's environmental impacts, and summarizes as applicable any mitigation measures used to minimize environmental effects.

RD has conducted an independent evaluation of the environmental assessment and believes that it accurately assesses the impacts of the proposed project. No significant impacts are expected as a result of the construction of the project.

Questions and comments should be sent to RD at the address provided. RD will accept questions and comments on the environmental assessment for 14 days from the date of publication of this notice.




A general location map of the proposal is shown below.
